Prerequisites

All students must have a current BLS CPR or equivalent CPR certification **prior to** the beginning of class. All students must be 16 years or older at the beginning of class. Online access is required to complete this program. You must have a NREMT account, NJ OEMS account prior to registration. Visit www.nremt.org and www.njems.us to create these accounts.

Tuition, Textbook, and Supplies

\$1,500 tuition plus \$325 Administration fee which includes the textbook and online platform. Payments are due with registration.

NJ Training Fund Form (for eligible volunteer agencies) does not cover Administration fees.

A blood pressure cuff and stethoscope are required for class - they are available from us at a cost of \$25/each. Other equipment is also available.

Refund Policy

10 or more days prior to the start of class - 100% refund minus \$25 administrative fee, less than 10 days prior to the start of class - 50% refund minus \$25 administrative fee, **no refunds issued on or after the start of class.**

About the hybrid program

This class is recommended for students who are at a college level of learning. You are expected to have good study habits, and the ability to independently study before class. There is a **GREAT** amount of reading for this class - please plan for 10-15 hours/week. Lectures are provided online. Our in-class time is dedicated to skills only. Completion of all lectures and online quizzes is required for completion of the class. You must have reliable internet access in order to complete this class.

Class Attendance

Due to the nature of a hybrid program **ALL in-class sessions are mandatory.** Skill sessions are integral to becoming an EMT. We have invested much time and effort into your EMT program, please do the same for us. CSC has submitted class hours, including online time, to the State of New Jersey. In order to complete the class, we must prove to the state you were present during all sessions - or have made arrangements to make time at another CSC EMT program. We cannot accept make-up sessions from other training agencies, other healthcare providers, etc.

Removal From the Program

As per NJAC 8:40A-5.8 "A person must successfully complete each of the program curriculum's seven training modules, and shall not be permitted to move on to the next consecutive module until he or she has successfully passed the examination for the previous module. A person who fails a module examination shall be permitted to re-test following remediation. **A person who fails two consecutive examinations for the same module shall be automatically expelled from the EMT- Basic training program and shall be required to apply for, and participate in, an entirely new EMT-Basic training program.** "

Dress Code

A collared white shirt (polo or button down), blue or black dress pants/ or BDU's (no jeans or stretchy pants), Black safety shoes (boots preferred), a watch (showing seconds), stethoscope and nametag are required for the EMT program. You are expected to dress in the student uniform during all sessions. A name-tag will be provided for you. Stethoscopes are available for purchase at our office, or available at retail/online stores.

Books

The AAOS 12th Edition **Premier Package EMT textbook is required for class** - books can be purchased on the first day of class. On the first day, a course ID will be assigned to you for the online component of the class. An electronic student handbook will be provided on the first day of class. The handbook outlines our policies, procedures, guidelines, and expectations for the program. It will serve as a valuable resource during your education, and practice, as an EMT.

NJ Registration

Registration with the NJDOH is required for class. Please visit www.njems.us Create an account and apply for EMT Initial Standard Certification. We must register you on the first day of class with the State of New Jersey.

An NREMT account is also required. Go to www.nremt.org create an account, and create application for certification

Certification Testing

Once you are complete with the course we will mark you as eligible for certification testing. You will register for the exam through NREMT's website. The NREMT exam costs approximately \$80 per attempt. For candidates paying for class through the NJ Training Fund, your initial attempt is also paid by the NJ Training Fund. Subsequent attempts are not covered.

You must be present on the date you select, as you will be charged for any changes in dates or no-shows.
