The New CSC EMT HYBRID PROGRAM 2012

The EMT program in the State of New Jersey is changing to the new National Emergency Medical Services Education Standards. The program will now be on-line reading, classroom lecture and practical training, plus 10 hours of either in-hospital or ambulance ride-along time.

Before registering, please be aware of the following requirements for the CSC EMT course.

All students must:

1. Have easy access to a computer. Expect to complete approximately 8-12 hours a week online independent study.
2. Be able to read, write, communicate, and interpret instructions in the English language. (All text materials are written at the 10th grade level).
3. Be in good physical condition and be able to lift.
4. Participate in all lecture and practical sessions. Students must attend all sessions in their entirety. Any absences must be made up prior to the state final certification exam.

DUE TO THE INTENSIVE NATURE OF THIS COURSE, MAKE-UP SESSIONS WILL BE EXTREMELY DIFFICULT TO SCHEDULE.

5. Purchase a textbook for \$100 and a stethoscope for \$20. They can both be bought at CSC either prior to, or the first day of class. Bring cash, check or money order for payment.
6. Pick up a student handbook at our office, at 1 Safety Place, Metuchen, NJ 08840 once your registration and payment are complete. There is no charge for this handbook. It contains the rules and regulations, skill sheets, and the rest of the information you will need.
7. Bring a stethoscope and watch with a second hand to all skill sessions.
8. Have a notebook and pencil/pen at all times.
